ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the said ASSIGNOR by these presents does hereby assign and transfer unto the said ASSIGNEE, its successors and assigns, its entire right, title and interest in and to the HUMMER Trademark throughout the world, together with that part of the goodwill of the ASSIGNOR's business connected with the use of and symbolized by the HUMMER Trademark. This assignment includes the registration for the Hummer Trademark set forth on the attached Schedule A, as well as all right, title and interest the ASSIGNOR may have to the HUMMER Trademark in all countries or jurisdictions of the world, whether by use, registration, application or otherwise.

The said ASSIGNOR represents that it does not own any other registration or application for the HUMMER Trademark, in any country or jurisdiction, other than that listed in the attached Schedule A, and should same exist, by this assignment ASSIGNOR does hereby transfer all of its rights, title and interest thereto to ASSIGNEE.



ASSIGNOR also agrees not to attempt to register or to use or to aid any third party in attempting to register or to use any trademark or service mark which may be confusingly similar to the HUMMER Trademark.

The provisions herein extend to successors and/or assigns of the parties.
