R.P. Scherer South, Inc., a United States company of 2725 Scherer Drive, St. Petersburg, FL (the "Assignor") of the first part


And

A Deed of Assignment is executed which is ruled by the following terms:


1. The Assignor is the proprietor of Trademarks listed in Exhibit A.
