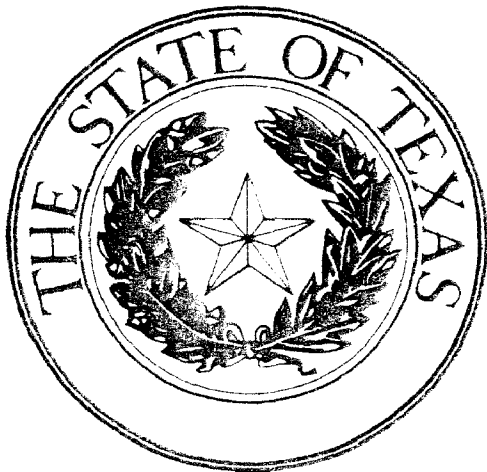

1. Metro Optics of Austin, Inc. Incorporated certifies as follows:
  - (a) Metro Optics of Austin, Inc. is a Texas corporation, formed on October 17, 1989.
  - (b) A Plan of Conversion has been approved by the shareholders.




5. **Purpose.** This Limited Partnership is being created pursuant to a plan of conversion.
