Pursuant to the provisions of the Washington Business Corporation Act, as amended, these Articles of Amendment to the Amended and Restated Articles of Incorporation of Netstock Corporation, a Washington corporation (the "**Corporation**"), are herewith submitted for filing.

1. The name of the Corporation is Netstock Corporation.
2. Article I of the Amended and Restated Articles of Incorporation of the Corporation is amended as follows:


"ARTICLE I. NAME
