RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT OF TRADEMARKS dated April 30, 2004 by Harris Trust and Savings Bank, as Agent as hereinafter described;

WITNESSETH:

WHEREAS, Harris Trust and Savings Bank, as Agent, an Illinois banking corporation with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603 (the "Secured Party") and Turtle Wax, Inc, an Illinois corporation with its mailing address at 5655 West 73rd Street, Chicago, Illinois 60638-6211 (the "Pledgor") are parties to a certain Trademark Collateral Security Agreement dated March 21, 2003 which was recorded in the United States Patent and Trademark Office on March 25, 2003 at Reel 002698, Frame 0808 (the "Assignment"), pursuant to which the Pledgor granted a security interest in and collateral assignment of certain trademarks and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "Trademarks"); and

WHEREAS, the Pledgor has requested that the Secured Party release its security interests in the Trademarks and reassign the same to the Pledgor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

The Secured Party hereby releases its security interests in and collateral assignment of, and reassigns, grants and conveys to the Pledgor, without any representation, warranty, recourse or undertaking by the Secured Party, all of its right, title and interest, if any, in and to:

(i) Each trademark, trademark registration and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application; and

(ii) All proceeds of the foregoing, including without limitation any claim by Pledgor against third parties for damages by reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration or trademark application, in each case together with the right to sue for and collect said damages.
