ARTICLE ONE

The name of the corporation is OWEN HEALTHCARE, INC.

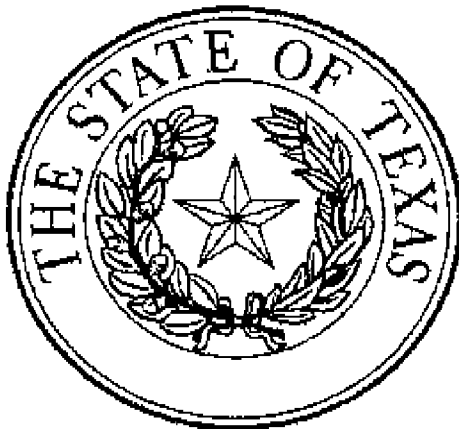
