ASSIGNMENT

WHEREAS, Weyerhaeuser Real Estate Company, a Washington Corporation, located at 33940 Weyerhaeuser Way South, Federal Way WA 98001-9663, the record owner and assignee of the entire right, title and interest in the following mark and its registration:

Be it known that for and in consideration of the sum of One and No/100 Dollars (\$1.00) and other good and valuable consideration receipt of which is hereby acknowledged, said Weyerhaeuser Real Estate Company hereby acknowledges as of December 1, 2001, the aforesaid sale, assignment and transfer, and by these presents does sell, assign and transfer unto C.P. Morgan Co. the entire right, title and interest in and to said Mark and its Registration, together with the goodwill of the business symbolized by said mark, together with any license rights therein, together with all rights of action, in law or in equity, for any past or future infringement thereof and damages and other remedies therefore.

Said Mark and its registration are to be held and enjoyed by C.P. Morgan Co., Inc. for its own use and benefit and for its successors and assigns to the full end of the present or extended term for which said registration has been granted, as fully and entirely as the same would have been held by Weyerhaeuser Real Estate Company if this assignment and sale had not been made.

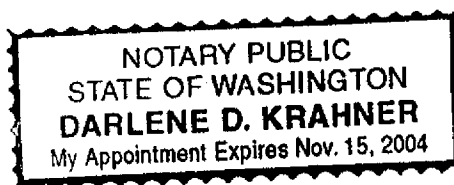
