ASSIGNMENT

[2] NMMA further agrees that immediately upon receipt of said good and valuable consideration, it (a) shall obtain from the Secretary of State of Arkansas' website an Assignment of Registration form of the State of Arkansas Registration, and it shall complete and file such form with the Arkansas Secretary of State's Office and, (b) shall obtain an Assignment of Trademark form and file same with the United States Patent and Trademark Office for Reg. No. 2,251,067, each reflecting an assignment of the MARKS to D&G Attractions, Inc.


[3] NMMA warrants that, to the best of its knowledge and belief, it knows of no outstanding claims to the MARKS.
