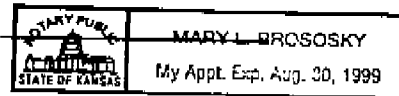


EXHIBIT A**PLAN OF MERGER**

1. Sealright Packaging Company of Missouri is the survivor.
2. All of the property, rights, privileges, leases and patents of Indopak, a California Corporation, are to be transferred to and become the property of Sealright Packaging Company, the survivor. The officers and board of directors of the above named corporation are authorized to execute all deeds, assignments, and documents of every nature which may be needed to effectuate a full and complete transfer of ownership.
3. The officers and board of directors of Sealright Packaging Company shall continue in office until their successors are duly elected and qualified under the provisions of the bylaws of the surviving corporation.
4. It is agreed that, upon and after the issuance of a certificate of merger by the Secretary of State of the State of Missouri:
 - a. The surviving corporation may be served with process in the State of Missouri in any proceeding for the enforcement of any obligation of any corporation organized under the laws of the State of Missouri which is a party to the merger and in any proceeding for the enforcement of the rights of a dissenting shareholder of any such corporation organized under the laws of the State of Missouri against the surviving corporation;
 - b. The Secretary of State of the State of Missouri shall be and hereby is irrevocably appointed as the agent of the surviving corporation to accept service of process in any such proceeding; the address to which the service of process in any such proceeding shall be mailed is 9201 Packaging Drive, DeSoto, KS 66018.
 - c. The surviving corporation will promptly pay to the dissenting shareholders of any corporation organized under the laws of the State of Missouri which is a party to the merger the amount, if any, to which they shall be entitled under the provisions of "The General and Business Corporation Law of Missouri" with respect to the rights of dissenting shareholders.
5. The articles of incorporation of the survivor are not amended.
