

PLAN OF MERGER

- Sealright Packaging Company of Missouri is the survivor.
- 2. All of the property, rights, privileges, leases and patents of Indopak, a California Corporation, are to be transferred to and become the property of Sealright Packaging Company, the survivor. The officers and board of directors of the above named corporation are authorized to execute all deeds, assignments, and documents of every nature which may be needed to effectuate a full and complete transfer of ownership.
- 3. The officers and board of directors of Sealright Packaging Company shall continue in office until their successors are duly elected and qualified under the provisions of the bylaws of the surviving corporation.
