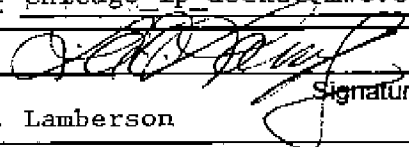

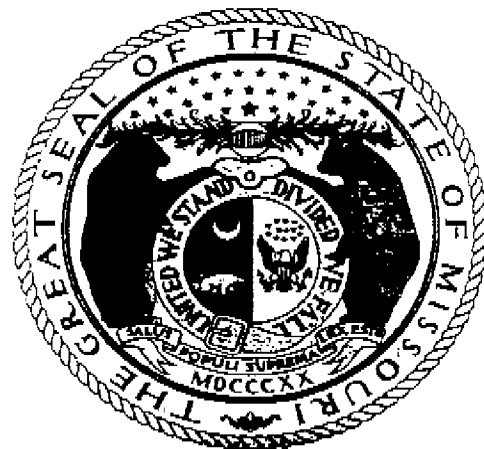

ARTICLES OF INCORPORATION

The undersigned, Sealright Packaging Company, a Missouri corporation (the "Corporation"), for the purpose of amending the Articles of Incorporation of the Corporation, in accordance with The General and Business Corporation Law of Missouri, does hereby make and execute this Certificate of Amendment of Articles of Incorporation and does hereby certify that:

- I. The name of the Corporation is Sealright Packaging Company.
- II. The amendment set forth below was adopted by the shareholders of the Corporation on November 14, 1996.
- III. The following resolution of the shareholders sets forth the amendment adopted:

RESOLVED, that Article I of the Articles of Incorporation is hereby amended to read as follows:

Article I

The name of the corporation is Sealright Manufacturing - West, Inc.

- IV. The number of shares of stock of the Corporation outstanding and the number of shares entitled to vote on the amendment was 30,000 shares of common stock.

The foregoing amendment was, in accordance with the provisions of The General and Business Corporation Law of Missouri, adopted by written consent signed by all of the shareholders of the Corporation entitled to vote thereon, such consent having the same force and effect as a unanimous vote of the shareholders thereon at a meeting duly held. Accordingly, the number of shares of the Corporation voted for the amendment was 30,000, and the number voted against the amendment was 0.
