ASSIGNOR hereby authorizes the Commissioner for Patents and Trademarks of the United States to issue the TRADEMARK RIGHTS to ASSIGNEE in accordance with the terms of this instrument.

ASSIGNOR does not warrant the validity of the TRADEMARK RIGHTS.

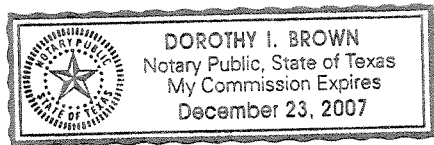
