**DEED OF ASSIGNMENT OF TRADE MARKS**

---

A DEED OF ASSIGNMENT OF TRADE MARKS made on 30 April 2004

**BETWEEN**

- (1) **INDOPCO, INC.**, acting on its own behalf and on behalf of its business unit, Quest International Flavors & Food Ingredients Company, a company incorporated in Delaware (identification number 13-1522451) whose registered office is at 10 FINDERNE AVENUE, BRIDGEWATER, NEW JERSEY 08807 (the *Assignor*); and
- (2) **KERRY GROUP SERVICES LTD** a company incorporated in Ireland (registered number 116550) whose registered office is at Princes Street, Tralee, Co. Kerry (the *Assignee*).

**WHEREAS**

(A) The Assignor is the registered proprietor of the trade mark registrations (the *Trade Marks*) and the applicant for the trade mark applications (the *Applications*) set out in Schedule 1.

(B) Pursuant to the master sale and purchase agreement between Imperial Chemical Industries PLC (*ICI*) and Kerry Group PLC (*Kerry*) dated 1 March 2004 (the *Agreement*), ICI agreed to sell and transfer (or procure the sale and transfer of) and Kerry agreed to purchase (or procure the purchase of), *inter alia*, the Trade Marks and the Applications.

**IT IS AGREED** as follows:

**1. ASSIGNMENT**

The Assignor hereby assigns to Assignee all of the Assignor's right, title and interest in and to the Trade Marks and the Applications, including (without limitation):

- (a) all statutory and common law rights attaching to the Trade Marks and the Applications; and
- (b) the right to sue for and obtain injunctive relief, damages and all other relief in respect of any infringement or misuse (whether past, present or future) of any of the Trade Marks, Applications or trade marks granted pursuant to any Application.

**2. FURTHER ASSURANCE**

The Assignor shall, at the request of the Assignee and at the Assignee's cost, execute all documents and do all things necessary to vest in the Assignee all rights assigned to the Assignee under this Deed of Assignment and to give the Assignee the full benefit of this Deed of Assignment.

**3. COUNTERPARTS**

This Deed of Assignment may be executed in any number of counterparts, and by the parties to it on separate counterparts, but shall not be effective until all the parties have executed at least one counterpart but all the counterparts shall together constitute but one and the same instrument.

**4. LAW AND JURISDICTION**

This Deed of Assignment shall be governed by and construed in accordance with English law. Each party agrees that the courts of England and Wales are to have non-exclusive jurisdiction to settle any claim or matter arising under this Deed of Assignment and each party submits to the jurisdiction of the English courts.


