

RELEASE

THIS RELEASE, dated as of the 28<sup>th</sup> day of March, 2003 (this "Release"), is made by THE JACKSON NATIONAL LIFE INSURANCE COMPANY, through its agent, PPM AMERICA, INC. (the "Secured Party"), in favor of AVERY DENNISON CORP., a Delaware corporation ("AVERY DENNISON").

PRELIMINARY STATEMENTS:

A. Reference is made to (1) the Revolving Credit and Term Loan Agreement, and (2) the Subordinated Term Loan Agreement, in each case dated as of May 26, 1995, as amended, among Industrial Coatings Group, Inc. ("ICG"), GCI Holdings Corporation ("GCI"), Jackson National Life Insurance Company and Jackson National Life Insurance Company of Michigan (such agreements, the "Loan Agreements").

B. Reference is further made to the Asset Purchase Agreement by and among Avery Dennison, The Holliston Mills, Inc. ("HM"), ICG and GCI dated March 28, 2003 (the "Asset Purchase Agreement"). All capitalized terms not otherwise defined shall have the meanings ascribed to them in the Asset Purchase Agreement.

C. Pursuant to the terms of the Asset Purchase Agreement, HM, IGC and GCI are selling the Purchased Assets to Avery Dennison. In connection with that sale, Avery Dennison requests that the Secured Party release any and all liens and security interests that the Secured Party may possess in the Purchased Assets.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. The Secured Party releases all liens and security interests granted to it by HM, ICG and GCI in the Purchased Assets.

2. Without limiting the foregoing, the Secured Party releases any security interest it may have in the trademarks assigned pursuant to the Asset Purchase Agreement, including, without limitation, that trademark identified on Exhibit A attached hereto.

3. The Secured Party further agrees that it shall execute and file, at the cost and expense of Avery Dennison, termination statements to the extent requested by Avery Dennison in order to further effectuate the intent and purpose of this Release.


