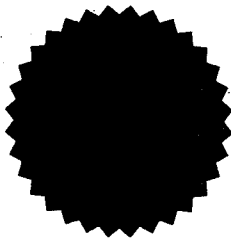

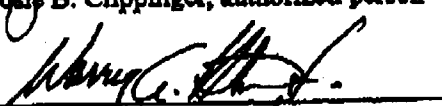
1. The name of the limited liability company is DMW Acquisition LLC.
