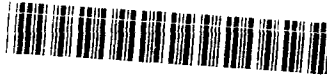

4. That the Certificate of Incorporation of Capstar Radio Operating Company shall be the Certificate of Incorporation of the surviving corporation.




