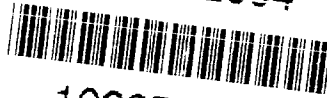

LAW PROS, filed with the United States Patent and Trademark Office on March 26, 1998, registration number 2,295,267;


LAW PROS, a New Jersey State trademark, registration number 15591;
