3. In exchange for valuable consideration received, FLEET hereby releases its security interest in the trademarks and trademark applications identified on the attached Exhibit A.

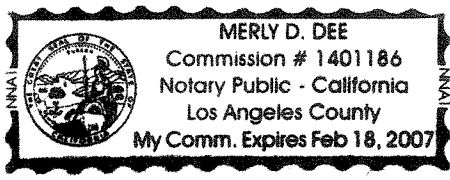


