**RELEASE OF ASSIGNMENT OF TRADEMARK**



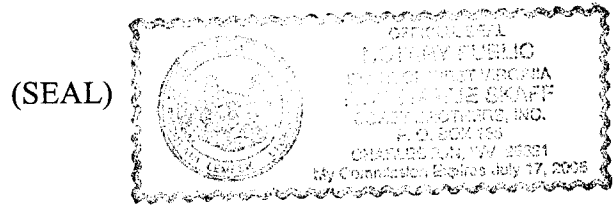
