I. The name of the corporation is LifePath, Inc.

II. The Articles of Incorporation of LifePath, Inc. are hereby amended by deleting all references to LifePath, Inc. and replacing it with LifePath Hospice and Palliative Care, Inc. for the sole purpose of changing the name of the corporation.

III. At a regular meeting of the Board of Directors of the corporation, said Board being the sole members of the corporation, held on the 3rd day of April, 2001, for which notice was given of the intent to amend these Articles, and at which a quorum was present. A vote of greater than two-thirds (2/3) of the members present in voting was held in favor of adopting this amendment. A two-thirds (2/3) vote of the members was sufficient for approval.
