RELEASE OF LIENS AGREEMENT

July 2, 2004

TO: The Weetabix Company, Inc.
Barbara's Bakery, Inc.
Weetabix Limited
Weetabix of Canada Limited
Northern Gold Foods Ltd.

(collectively, the "**Debtors**")

RE: A £670,000,000 senior credit facilities agreement (the "**Senior Credit Agreement**") dated 9 December 2003 (as amended by amendment letters dated 19 December 2003, 6 February 2004 and 12 February 2004) between, inter alios, Latimer Group Limited, Latimer Acquisitions Limited as the borrower, J.P. Morgan plc as arranger, JPMorgan Chase Bank as underwriter and J.P. Morgan Europe Limited as agent, security agent and documentation agent (the "**Security Agent**").

WHEREAS, Weetabix Limited entered into a Stock Pledge Agreement (governed by the law of the State of New York) dated February 12, 2004 wherein it granted a security interest in the Pledged Collateral (as defined therein) of The Weetabix Company, Inc. in favour of the Security Agent;

WHEREAS, The Weetabix Company, Inc. entered into a Stock Pledge Agreement (governed by the law of the State of New York), dated February 12, 2004 wherein it granted a security interest in the Pledged Collateral (as defined therein) of Barbara's Bakery, Inc. in favour of the Security Agent;

WHEREAS, The Debtors, entered into a Security Agreement (governed by the law of the State of New York), dated February 12, 2004 wherein each Debtor granted a security interest in the Collateral (as defined therein) in favour of the Security Agent;

(the foregoing Stock Pledge Agreements and Security Agreements being referred to herein collectively as the "**Security Documents**").

AND WHEREAS, the Debtors have requested the Security Agent to execute and deliver this Release of Liens Agreement and the Security Agent has agreed that the assets of the Debtors charged under the Security Documents are to be released.

NOW THEREFORE, this Release of Liens Agreement witnesses that:

- 1 The Security Agent hereby releases and forever discharges the Debtors from any and all security interests created under the Security Documents, including without limitation the security interest on the intellectual property set forth in Exhibit 1.
- 2 The Security Agent hereby agrees that it will promptly upon request execute and deliver to the Debtors, at the Debtors expense, releases and discharges in registrable form of all security interests created under the Security Documents, in form and substance reasonably acceptable to the Security Agent.

- 3 The Security Agent hereby delivers to Weetabix Limited all certificates in the Security Agent's possession evidencing the Pledged Collateral under the applicable Stock Pledge Agreement, and Weetabix Limited acknowledges receipt of such certificates and confirms that such certificates constitute the only certificates on the property delivered to the Security Agent under such Stock Pledge Agreement.
- 4 The Security Agent hereby delivers to The Weetabix Company, Inc., all certificates in the Security Agent's possession evidencing the Pledged Collateral under the applicable Stock Pledge Agreement, and The Weetabix Company, Inc. acknowledges receipt of such certificates and confirms that such certificates constitute the only certificates on the property delivered to the Security Agent under such Stock Pledge Agreement.
- 5 Any capitalized terms used herein and not otherwise defined shall have the meanings attributed thereto in the Senior Credit Agreement.
- 6 This Release of Liens Agreement shall enure to the benefit of the Debtors and their respective successors and assigns.
- 7 This Release of Liens Agreement shall be governed by the law of the State of New York. This Release of Liens Agreement may be executed in any number of counterparts, each of which, when so executed, shall be an original and all of which, taken together, shall constitute one and the same Agreement.


