THE ARTICLES OF INCORPORATION  
OF PADUCAH NEWSPAPERS, INCORPORATED

The Articles of Amendment to the Articles of Incorporation of Paducah Newspapers, Incorporated, are as follows:

ARTICLE I

The name of the corporation is Paducah Newspapers, Incorporated.

ARTICLE II

The text of each amendment adopted is "That the name of the corporation be changed to Paxton Media Group, Inc."

ARTICLE III

The adoption of this amendment was recommended by the Board of Directors to the shareholders at a duly authorized meeting of the Board of Directors of the corporation by unanimous vote April 14, 1994. The amendment was adopted April 15, 1994, at the annual meeting of the shareholders, with all of the shareholders voting "yes," except one who abstained. There was no voting group entitled to vote separately.
