**ASSIGNMENT OF TRADEMARKS

WHEREAS, Skylark Meats, Inc. a Nebraska Corporation ("Skylark") with offices at 4430 S 110th Street Omaha NE 68137-1217 is purchasing certain of the assets of Big City Reds related to the sale and distribution of Big City Reds hotdogs and other specialty meats and is desirous of documenting its acquisition of the Marks (a sample of which is attached hereto);

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, as follows:


1. Assignment. Big City Reds does assign unto Skylark, all right, title and interest in and to such Marks, together with the goodwill of the business symbolized by the Marks, and Big City Reds agrees to execute and deliver such additional documents as may be reasonably required to evidence assignment of such Marks to Skylark Meats, Inc.; and


2. Effective Date. The effective date of this Assignment shall be December 19, 2003.


3. Consent. Michael Sternberg consents to the use of the Marks bearing his name by Skylark.

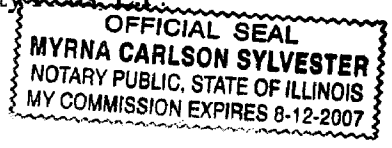


