TERMINATION OF SECURITY INTERESTS IN TRADEMARKS

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Lender hereby terminates and releases the Trademark Security Agreement and any security interests, liens, mortgages or other encumbrances granted to the Lender, including without limitation under the Trademark Security Agreement, in and to:


1. all right, title and interest in the trademarks identified on Schedule A; and
