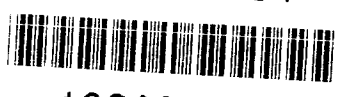

NUNC PRO TUNC ASSIGNMENT OF TRADEMARK RIGHTS

This Nunc Pro Tunc Assignment of Trademark Rights is made and entered into as of this 28th day of January 2004, with an effective date of 8 October 1998. Sport Court, Inc., a corporation existing under the laws of the State of Utah, having a principal place of business at 939 South 700 West, Salt Lake City, Utah 84104 (referred to hereinafter as "Sport Court"), is the owner of all right, title, and interest in Trademark Registration No. 1,276,329 for DURAGRID.

Snap Lock Industries, Inc., a corporation organized and existing under the laws of the State of Utah, and having a place of business at 1735 South 900 West, Salt Lake City, Utah 84104 (referred to hereinafter as "Snap Lock"), is desirous of acquiring all right, title, and interest in United States Trademark Registration No. 1,276,329 for DURAGRID, as well as all corresponding foreign trademark rights, if any, held by Sport Court.

In consideration of payment of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is acknowledged by the parties, Sport Court hereby sells, assigns, and transfers to Snap Lock the entire right, title, and interest in U.S. Trademark Registration No. 1,276,329, as well as all common law rights associated with the mark and corresponding foreign trademark rights, if any, held by Sport Court, and any other rights stemming from such U.S. and foreign trademark rights. Sport Court also transfers to Snap Lock all of the goodwill of the business connected with the use of and symbolized by the respective trademark. Sport Court further assigns to Snap Lock all rights, if any, to pursue past infringement of such trademark rights along with the right to recover damages for past infringement.

Sport Court hereby authorizes and requests any concerned agency, office, or entity to record Snap Lock as the assignee of Sport Court's entire right, title, and interest in such trademark rights.
