# TRADEMARK AND SERVICE MARK ASSIGNMENT

Assignor hereby authorizes Assignee, and its successors and assigns, to the fullest extent permitted by applicable law, to file in its own name applications for trademark and copyright registration in the United States and in foreign countries in connection with the Mark, and to secure in its own name the registrations granted thereon. Assignor also hereby appoints Assignee as its agent to act in Assignor's name and on Assignor's behalf to take any action necessary to effect the transfer of any of the Mark to Assignee, or prosecute or otherwise enforce any claims, rights or benefits relating to the Mark.
