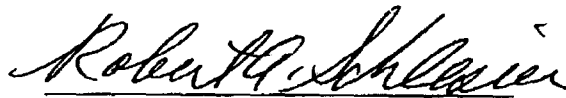

I. NAME

*The name of the corporation (hereinafter referred to as corporation) is
