WHEREAS, it is desired that the assignment of such MARK be made of record in the United States Patent and Trademark Office.

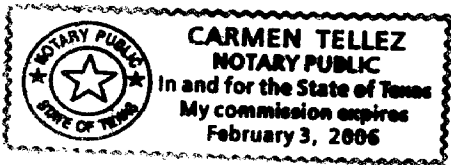
