**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of June 24, 2004, from JPMorgan Chase Bank (as successor-in-interest to The Chase Manhattan Bank), a New York banking corporation, as Administrative Agent (the "Agent") for certain banks and other financial institutions, to Innovative Acquisition Company, Inc. (as successor-in-interest to Innovative Folding Carton Company, Inc.), a Delaware corporation, with its principle place of business located at 3950 Paramount Boulevard, Suite 100, Lakewood, California 90712, c/o Impaxx, Inc. ("Innovative").

WITNESSETH:

WHEREAS, pursuant to the Amended and Restated Subsidiaries Security Agreement, dated as of July 8, 1999, made by the Grantors (as defined therein), including Innovative, in favor of the Agent (the "Collateral Agreement"), a security interest (the "Security Interest") was granted by the Grantors to the Agent in certain collateral, including the Trademark (as hereinafter defined);

WHEREAS, the Collateral Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on October 23, 2001, at Reel 2386 and Frame 0373; and


WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. The term "Trademark," as used herein, shall mean all of Innovative's right, title and interest of every kind and nature as of the date hereof in the Trademark listed on Schedule A attached hereto.
2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Trademark, and any right, title or interest of the Agent in such Trademark shall hereby cease and become void.
3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.

IN WITNESS WHEREOF, the undersigned has executed this Termination and Release by its duly authorized officer as of the date first above written.


