TERMINATION OF TRADEMARK COLLATERAL ASSIGNMENT AND
SECURITY AGREEMENT

WHEREAS, TRIPAC INTERNATIONAL, INC. (hereinafter "TRIPAC"), a Texas corporation, and BANK ONE, TEXAS NATIONAL ASSOCIATION (hereinafter "BANK ONE"), a National (U.S.A.) Banking Association, entered into various financial arrangements, under the terms of which BANK ONE made certain advances of money and extended certain financial accommodations to TRIPAC, and pursuant to the terms of which TRIPAC granted to BANK ONE a security interest in certain of its assets, including Trademarks identified in Exhibit A hereunto attached;

WHEREAS, a Trademark Collateral Assignment and Security Agreement for said assets was entered into between TRIPAC and BANK ONE on April 5, 1995 and was duly recorded in the United States Patent and Trademark Office on April 11, 1995, in Volume 1331, Page 0015; and


WHEREAS, all loans made by BANK ONE to TRIPAC, pursuant to said financial arrangements, have now been fully paid and satisfied by TRIPAC.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, BANK ONE hereby:

1. Terminates and releases to TRIPAC its security interest in and to all of the assets of TRIPAC identified in said Trademark Collateral Assignment and Security Agreement (collectively, the "TRIPAC Trademark Assets"), including, but not limited to, the Trademark Certificate of Registration identified on Exhibit A.
2. Authorizes and requests the Commissioner of Patent & Trademarks of the United States of America and the empowered officials of all other governments to note and record the termination and release of the security interest granted hereunder with respect to said Trademarks, its Certificate of Registration and the other assets identified in said Trademark Collateral Assignment and Security Agreement.
3. Reassigns to TRIPAC, without warranty or recourse of any nature, all the interest of BANK ONE, in the TRIPAC Trademark Assets.

IN WITNESS WHEREOF, BANK ONE has caused this Termination of Intellectual Property Security Agreement to be signed by its authorized officer, this 30th day of JANUARY, 2004.
