## EPRESSURE SPECIFIED INTELLECTUAL PROPERTY ASSIGNMENT

WHEREAS, EPRESSURE, INC., a Delaware corporation ("ePressure, Inc."), entered into a written Agreement of Purchase (the "Agreement of Purchase") dated November 8, 2000 (the "Effective Date"), by and among, (i) ePressure, Inc., DYNISCO, INC., a Delaware corporation ("Dynisco, Inc."), DYNISCO EUROPE HOLDINGS, B.V., a company organized in the Netherlands ("Dynisco Europe"), DYNISCO EXTRUSION, INC., a Delaware corporation ("Dynisco Extrusion"), and DYNISCO POLYMER TEST, INC., a Pennsylvania corporation ("Dynisco Polymer Test" and together with ePressure, Inc., Dynisco, Inc., Dynisco Europe and Dynisco Polymer Test, the "Sellers"), and (ii) DYNISCO LLC, a Delaware limited liability company ("Dynisco LLC"), DYNISCO INSTRUMENTS LLC, a Delaware limited liability company ("Dynisco Instruments"), EXTRUSION MERGER COMPANY INC., a Delaware corporation ("Extrusion Merger Company"), and POLYMER TEST MERGER COMPANY INC. ("Polymer Merger Company" and together with Dynisco LLC, Dynisco Instruments and Extrusion Merger Company, the "Buyers");

WHEREAS, the defined terms used herein are defined in the Agreement of Purchase;

WHEREAS, ePressure, Inc. is the owner, free and clear of any Encumbrances, of the entire right, title and interest in and to the Intellectual Property specified below (the "Specified Intellectual Property");

WHEREAS, ePressure, Inc. desires to sell, transfer, assign and deliver to Dynisco Instruments all right, title and interest in and to the Specified Intellectual Property, including all of the business of ePressure, Inc. to which the Specified Intellectual Property pertains, on the terms set forth in the Agreement of Purchase;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, ePressure, Inc. sells, transfers, assigns and delivers to Dynisco Instruments, effective as of the Effective Date, all right, title and interest in and to the Specified Intellectual Property (including any registrations, registration applications, and renewals thereof), together with all goodwill of the business associated with and symbolized by the Specified Intellectual Property, and the right to seek or obtain any recovery, whether monetary, injunctive or otherwise, from any person or entity for past, present or future infringement or other violation of any of the rights under the Specified Intellectual Property.
