Jurista hereby declares that the foregoing power is coupled with an interest and as such is irrevocable.

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, Steven Z. Jurista assigns to Mahi Networks, Inc. all right, title and interest to the Trademarks and the applications and registrations, in the United States and throughout the world together with the common law rights and goodwill of the business symbolized by the Trademarks and together with the right to recover for damages and profits from past infringements thereof, if any. The Commissioner of Patents and Trademarks is requested to issue the Certificate of Registration for the pending application, specifically RPR ON A WAVELENGTH, to Mahi Networks, Inc.
