ASSIGNMENT AGREEMENT

THIS ASSIGNMENT AGREEMENT is made on 28th day of May 2003

BETWEEN:

- (1) **FINANZ ST. HONORE B.V.**, a company incorporated in the Netherlands, whose principal place of business is at c/o Mees Pierson Trust, Herengracht 548, PO Box 990, 1017 AZ Amsterdam, The Netherlands ("Finanz"); together with **MARCAFIN S.A.**, a company incorporated in Switzerland, whose principal place of business is at 2 Place du Port, Geneva, Switzerland ("Marcafin"); and **FINANCIERA DE PERFUMERIA S.A.** a company incorporated in the Republic of Panama, whose principal place of business is at 50 Street, Global Bank Building, 6th Floor, Panama City, Republic of Panama ("Panama" and together the "Assignors"); and
- (2) **VÖRUMERKJASTÝRING EHF.**, a company incorporated in Iceland, whose registered office is located at Stórhofdi 23, 110 Reykjavik, Iceland (the "Assignee").

WHEREAS:

- (A) The Assignee has on the Completion Date entered in to one or more agreements related to the licensing of certain trademarks and other intellectual property owned by one or more of the Assignors, along with other related agreements.
- (B) The Assignors are the legal and beneficial owners of the Assigned Trade Marks and intend subject to the terms and conditions of this Assignment Agreement to assign the legal and beneficial ownership in the Assigned Trade Marks to the Assignee with full title guarantee.
- (C) All definitions used in the Agreement shall apply in this Assignment Agreement unless expressed otherwise.

IT IS HEREBY AGREED as follows:

1. DEFINITIONS

In this Assignment Agreement, unless the context otherwise requires, the following words and expressions shall bear the following meanings:

"Assigned Trade Marks" means those trade marks and all Intellectual Property related thereto owned by the Assignors and listed in Schedule "A" to this Assignment Agreement.

2. ASSIGNMENT

- 2.1 In consideration of the sum of One Hundred Thousand Dollars (\$100,000), the receipt of which is hereby acknowledged, the Assignors hereby sell, assign, transfer and convey with full title guarantee to the Assignee, its successors and assigns, all of Assignors' right, title and interest, including any and all common law rights, in and to the Assigned Trade Marks worldwide, together with their corresponding registrations and applications. Assignor agrees hereafter not to use any of the Assigned Trade Marks anywhere in the world without the permission of Assignee, except as may be stated otherwise specifically in Clause 3.1 or 3.3.
- 2.2 The Assignors hereby agree to execute specific confirmatory assignment and other supplementary documents (as may be required) in favour of the Assignee, for each of the countries in which there are Assigned Trade Marks detailed in the Schedule A in order to record (at the Assignee's expense) the assignment of the Assigned Trade Marks on the Registers of the countries detailed in the Schedule.
- 2.3 The Assignors, at the request of Assignee and at the Assignee's expense, further agree to co-operate and assist the Assignee in any legal requirements relating to the status, validity or enforceability of the Assigned Trade Marks, including providing Assignee with any information regarding use of the Assigned Trade Marks in connection with the prior manufacture, promotion, sale and advertising of any products bearing the Assigned Trade Marks.
- 2.4 Any and all representations and warranties made by Assignors to the Assignee with respect to the Assigned Trade Marks are set forth in the Agreement.
- 2.5 This assignment shall extend to and be binding upon all successors, licensees and assigns of the parties hereto.
- 2.6 All terms and conditions of the Agreement shall apply to this Assignment Agreement mutatis mutandis.
- 2.7 In the event of any conflict between the terms and conditions of this Assignment Agreement and the Agreement, the terms and conditions of the Agreement will prevail.

3. CLARIFICATION ON RIGHTS TO CERTAIN BRAND NAMES


- 3.1. Assignor currently is the registered owner or applicant of the trade marks "Chispas de Dana", "Iro Dana", "Priorite Dana", "Private Club Squash de Dana", "Squash Dana", and "Syrah by Dana" as set forth in Schedule A(2). Assignor hereby agrees to assign to Assignee all of Assignor's worldwide rights to the trade marks Chispas, Iro, Priorite, Private Club Squash, Squash and Syrah (said marks to be included in the definition of "Assigned Trade Marks"), but Assignee agrees that it shall not be permitted, except as may be licensed by Assignor, to use the term "by Dana" or "de Dana" with any of these or any other assigned marks. Assignor hereby agrees that hereafter it shall make no attempt to use the Assigned

Trade Marks (not including "Dana", "by Dana" or "de Dana") anywhere in the world except with the permission of Assignee.

- 3.2. Assignee agrees to register the Assigned Marks listed in Clause 3.1 and the Schedule into its name, and to amend existing registrations in Schedule A(2), or where necessary, register the Assigned Marks anew, so as to eliminate the "Dana", "by Dana" or "de Dana" reference. Assignor shall provide reasonable cooperation free of charge to Assignee in order to execute any documentation or take such other actions as is necessary for these amendments or re-registrations.
- 3.3. Notwithstanding any statement to the foregoing, the assignment of Assignor's rights in the Trade Mark "Herbissimo" shall not include any rights in "Herbissimo" owned by Perfumes Dana do Brasil Ltda., a subsidiary of Finanz and Panama, in Brazil, and such Brazilian rights, both via registration and usage, shall remain with Perfumes Dana do Brasil Ltda. However, all other rights to the Trade Mark Herbissimo, including those registrations listed in the Schedule, as well as all other rights arising worldwide outside of Brazil are included in this Assignment.




