TO
AMENDED AND RESTATED ARTICLES OF INCORPORATION

I
AMENDMENT

The Amended and Restated Articles of Incorporation of COMPOSITE STRUCTURES INC., a Nebraska corporation (the "Corporation"), are amended by revoking the current Article I and adopting the following in substitution thereof:

ARTICLE I

NAME
