
WHEREAS, the Assignor has agreed to reconvey Said Trademarks identified on Exhibit A attached hereto to the Assignee;

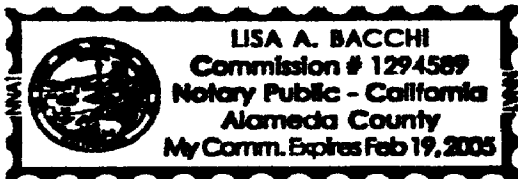
