**CONFIRMATORY ASSIGNMENT OF THE COLLATERAL ASSIGNMENT OF
PATENTS, TRADEMARKS AND LICENSES**

This Confirmatory Assignment by BSB Bank & Trust Company ("BSB") to K-6 Inc. ("K-6"), as set forth hereinbelow, is effective as of October 27, 2000.

WHEREAS, BSB Bank & Trust Company, a New York banking corporation having an office and a place of business at 58-68 Exchange Street, Binghamton, New York 13902, obtained, as a successor in interest by merger with Binghamton Savings Bank, a security interest in and a lien on certain patents, trademarks and licenses under a Collateral Assignment of Patents, Trademarks and Licenses dated January 12, 1989, as amended and supplemented from time to time, said Collateral Assignment and its respective amendments, restatements and prior assignments thereof collectively referred to as the "Collateral Assignment Agreement";

WHEREAS, prior to the said merger, Binghamton Savings Bank was acting as an Agent for itself, as a Bank, and for Chemical Bank and A.I. Associates, Inc., all parties to the Collateral Assignment Agreement;

WHEREAS, BSB acquired all rights of both Chemical Bank and A.I. Associates, Inc. under the Collateral Security Agreement, including their respective rights in the aforementioned patents, trademarks, and licenses;

WHEREAS, K-6 Inc., a Delaware corporation, having an office and a place of business at 300 Plaza Drive, Vestal, NY 13850, desired to and did acquire the entire right, title and interest in the said Collateral Assignment Agreement, as the sole lender and lien holder thereunder;

WHEREAS, BSB desires to confirm in this instrument its assignment and transfer of the entire right, title and interest in and to the Collateral Assignment Agreement and underlying security interest and liens on and as of October 27, 2000;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, BSB does hereby confirm that on, as of and effective October 27, 2000 it did assign, grant, convey and transfer unto K-6 its entire right, title and interest in, to and arising out of the Collateral Assignment Agreement and the underlying patents, trademarks and licenses and security interest and liens, and that, at the time of such assignment, BSB had the exclusive right and power to transfer its interest in the Collateral Assignment Agreement and rights arising thereunder.

This Confirmatory Assignment shall be binding upon K-6 and its successors and assigns, as the sole and exclusive lender and lien holder, and shall inure to the benefit of K-6, its successors and assigns, all effective as of October 27, 2000.
