**AFFIDAVIT OF BARRY HARRIGAN**

I, Barry Harrigan, hereby depose and state under oath as follows:

1. I am the Manager of Publish Media, LLC. I am over the age of 18 and competent to testify as to the matters contained in this affidavit. I also have personal knowledge of the matters contained herein.


2. Publish Media, LLC is a Delaware limited liability company with a principal place of business at 462 Boston, Street, Topsfield, Massachusetts, 01983 ("Publish Media").

3. On or about December 22, 2000, Publish Media entered into a Line of Credit and Security Agreement (the "Credit Agreement") with Eastern Bank Corporation, a Massachusetts savings bank corporation with a principal place of business at 270 Union Street, Lynn, Massachusetts 01901 (the "Bank"), which stated that as security for Publish Media's indebtedness to the Bank, Publish Media granted the Bank a security interest in, among other things, all of Publish Media's "tangible and intangible personal property" and "general intangibles."

4. Since that time, Publish Media has defaulted under the Credit Agreement and the Bank has accelerated payment in full of Publish Media's indebtedness to the Bank. As a result, on or about May 1, 2002, the Bank took possession of and title to all of Publish Media's "tangible and intangible personal property" and "general intangibles", pursuant to the Credit Agreement, including the trademarks set forth in the Amended Schedule A attached hereto, and applications, registrations, continuations and goodwill associated therewith (the "Trademarks").

5. Accordingly, the Bank became the sole owner of all of the right, title and interest in and to the Trademarks.
