## TRADEMARK ASSIGNMENT

WHEREAS, C.D.C. Acquisition Corporation d/b/a Construction Data Corporation, a corporation organized and existing under the laws of the state of New Jersey, and having a principal place of business at 2770 Indian River Boulevard, Vero Beach, Florida 32960 ("ASSIGNOR"), owns the entire right, title and interest in and to the United States trademark registration THE HOTSHEET, Registration Number 2,196,207 (the "Trademark"), and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the ASSIGNOR hereby sells, assigns and transfers unto the ASSIGNEE, and its successors and assigns, the entire right, title and interest in and to the Trademark, together with the good will of the business symbolized by the Trademark, and any trademark registration issued by any governmental agency in connection therewith, and further including: all income, royalties, and damages now and hereafter due and/or payable to ASSIGNOR, including without limitation, damages and payments for past or future infringements and misappropriations thereof, all rights to sue for past, present and future infringements, dilutions, or misappropriations thereof, and all rights corresponding to any of the above throughout the world;

AND THE ASSIGNOR HEREBY authorizes and requests the Commissioner of the United States Patent and Trademark Office and any Official of any state, country or countries foreign to the United States, whose duty is to issue trademark registration or other evidence or forms of intellectual property protection on applications as aforesaid, to issue the same to ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND THE ASSIGNOR HEREBY COVENANTS and agrees that the ASSIGNOR will communicate to the ASSIGNEE, its successors, legal representatives and assigns, any facts known to the ASSIGNOR respecting the Trademark, sign all lawful papers, make all rightful oaths, and generally do everything reasonably necessary to aid the ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper protection for the Trademark.
