

Assignor warrants that it is the lawful owner of all rights transferred to Assignee by this Assignment.

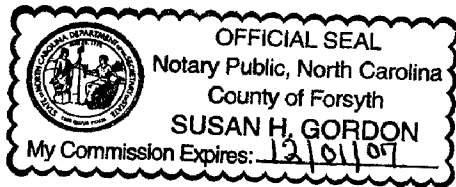


