RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL

This RELEASE, dated as of July 12, 2004, is made by Montreal Trust Company of Canada ("Montreal Trust") in favor of The Trader's Enterprises, Inc. (the "Borrower").

WITNESSETH:

WHEREAS, Montreal Trust was involved in a credit facility pursuant to which credit was extended to the Borrower, and in return the Borrower granted security interests pursuant to the following:

A Security Agreement dated November 24, 1995, between Montreal Trust and The Trader's Enterprises, Inc., recorded with the U.S. Patent and Trademark Office on March 22, 1996, Reel/Frame 1443/0540.

WHEREAS, Montreal Trust acknowledges full payment, performance and satisfaction of all obligations secured by the above-referenced Security Agreement; and


WHEREAS, the Borrower has requested that Montreal Trust release its security interest in the collateral described in the aforementioned Security Agreement (the "Collateral").

NOW, THEREFORE, Montreal Trust hereby **RELEASES** all of its security interest in the Collateral, namely, the trademarks listed Schedule A and the trademark registration listed in Schedule B, both schedules attached hereto and incorporated herein by reference, and any other collateral described in the aforementioned Security Agreement.

Montreal Trust agrees, at the Borrower's expenses, to cooperate with the Borrower and to provide the Borrower with the information and additional authorization necessary to effect the release of Montreal Trust's security interest in the Collateral.

IN WITNESS WHEREOF, Montreal Trust has executed this Release as of the date first set forth above.





