
RELEASE OF TRADEMARK SECURITY INTEREST



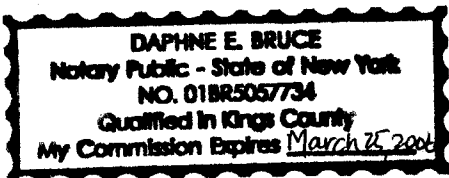
