TRADEMARK RELEASE

This TRADEMARK RELEASE granted on this 30th day of July, 2004, by CIBC WORLD MARKETS PLC, as Security Agent for various lenders (the "Assignee"), with principal offices at Cottons Centre, Cottons Lane, London SE1 2QL, England to NORTH AMERICAN NUTRITION COMPANIES, INC., a Delaware corporation (the "Assignor") with principal offices at 6531 State Route 503, P.O. Box 5002, Lewisburg, Ohio 45338, as follows:

WITNESSETH

WHEREAS, the Assignor has heretofore assigned and granted to the Assignee a security interest in and to the Marks as defined in the U.S. Security Agreement, dated as of November 29, 2002 (as amended from time to time, the "U.S. Security Agreement"), between the Assignee, the Assignor, and the other assignors from time to time party thereto, including, but not limited to certain U.S. trademarks, trademark registrations and trademark applications as more particularly set forth on Schedule A attached hereto (the "Marks") to secure the Obligations (as defined in the U.S. Security Agreement); and

WHEREAS, the Assignee wishes to release and restore all right, title and interest in and to the Marks to the Assignor and to dissolve any and all liens and encumbrances respecting the Marks;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Assignee hereby releases, discharges, quit claims and relinquishes unto the Assignor any and all right, title and interest in and to the Marks, and more particularly, the security interest in (i) the trademarks, trademark registrations and trademark applications as set forth on Schedule A hereto, (ii) all Proceeds (as such term is defined in the U.S. Security Agreement referred to above) of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date of the earliest assignment and grant hereunder for infringement of any of the Marks or unfair competition regarding the same, and granted to the Assignee by the Assignor by the U.S. Security

Agreement, which assignment was duly recorded including on January 27, 2003 at Reel 002662,
Frame 0394 in the United States Patent and Trademark Office.



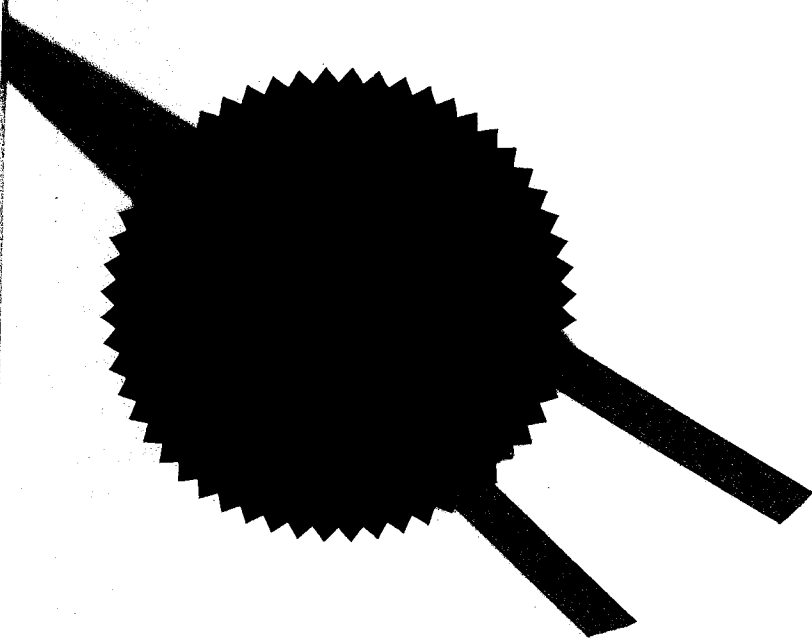
