## ASSIGNMENT OF TRADEMARK

This agreement is effective the 12<sup>th</sup> day of August, 2004, by and between Lowery Brothers Rigging Center, Inc., a corporation organized and existing under the laws of the State of Louisiana with its principal place of business located at 6100 Fourth Street, Marrero, Louisiana 70072 ("Assignor"), and Dreyfus-Cortney Inc., a corporation organized and existing under the laws of the State of Delaware with its principal place of business located at 2121 Poland Avenue, New Orleans, Louisiana 70117 ("Assignee").

WHEREAS Assignor is the owner of certain intellectual property rights including a trademark which is registered with the U.S. Patent and Trademark Office (the "Mark"); and

WHEREAS Assignee has acquired certain aspects of Assignor's business associated with the Mark, as well as all goodwill associated with this Mark; and

WHEREAS in connection with the acquisition of certain aspects of Assignor's business by Assignee, Assignor seeks to assign the Mark to Assignee, together with the goodwill associated with the Mark, subject to the terms of this Agreement;

### IT IS HEREBY AGREED AS FOLLOWS:

Assignor hereby assigns, transfers and sets over to Assignee, and its successors and assigns forever, all of its rights, title and interest in and to the Mark set forth on the attached Schedule A, together with the goodwill associated with the Mark, and any and all Assignor's rights of every kind, nature or description attaching to or which may attach to said trademark in the United States and entire world.

Assignor also grants Assignee a license to use the Mark in connection with Assignor's business, which license is exclusive to Assignee.
