TRADEMARK ASSIGNMENT (U.S.)

NOW, THEREFORE, EAGLE, in consideration of the sum of One Dollar (\$1.00) and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, agrees as follows

1. EAGLE hereby agrees to and does hereby sell, assign and transfer to INJECTRON, all of its rights, title, and interest in and to the Trademark Rights, including the right to sue others for past acts of infringement of the Trademark Rights and to retain all revenues received from others for past acts of infringement of the Trademark Rights.

2. EAGLE further agrees for itself, its predecessors, successors, and assigns to execute, without further consideration, any further legal documents, any further assignments, and any releases, declarations, renewals or other applications for Trademark Rights that may be deemed necessary by INJECTRON, or by INJECTRON's successors-in-interest or assigns, fully to secure

to INJECTRON, or to INJECTRON's successors-in-interest or assigns, EAGLE's interest as aforesaid in and to the Trademark Rights.
