## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement is delivered pursuant to that certain Intellectual Property Acquisition Agreement (the "Agreement") dated as of March 26, 2004 by and between General Instrument Corporation, doing business as the Broadband Communications Sector of Motorola, Inc., a Delaware corporation ("Buyer"), and Lantronix, Inc., a Delaware corporation ("Seller"). Capitalized terms used in this instrument have the same meanings given to them in the Agreement.

Seller does hereby sell, assign, and transfer to Buyer all of Seller's rights, title and interest in and to the Assigned Trademarks, whether registered or at common law, together with the goodwill of the business associated with the Assigned Trademarks, and all right, title and interest in any registrations or pending applications for the Assigned Trademarks, including, but not limited to those listed in the attached Annex A. Seller further hereby assigns any and all claims, demands, and causes of action for infringement of the Assigned Trademarks, past, present, and future, and all of the proceeds from the foregoing, accrued and unpaid and hereafter accruing.

Seller agrees that it will reasonably cooperate with Buyer and that it will sign and/or deliver to Buyer all documents reasonably necessary to record this assignment and any prior assignments or other transfers of ownership of the Assigned Trademarks in any country of the world.

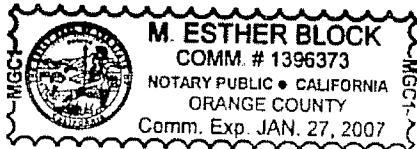
