RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of June 30, 2004 ("Effective Date") by and between **Verifone, Inc.**, a Delaware corporation and successor in interest to VeriFone mergerSub, Inc., a Delaware corporation, by operation of merger, with its chief executive office located at 2455 Augustine Drive, Santa Clara, California 95054 ("**Pledgor**") and **Foothill Capital Corporation**, a California corporation, with an office at 2450 Colorado Avenue, Suite 3000 West, Santa Monica, California 90404 ("**Pledgee**")

WHEREAS, pursuant to the terms and conditions of that certain Collateral Assignment of Trademarks by and between Pledgor and Pledgee dated July 1, 2002 (the "Trademark Security Agreement"), Pledgor granted to Pledgee a continuing security interest in and to all of Pledgor's right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Pledgor, including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto in each case, together with the goodwill associated therewith (collectively, the "Trademarks");

WHEREAS, Pledgor and Pledgee entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Loan and Security Agreement by and between Pledgor and Pledgee dated July 1, 2002 (the "Loan Agreement");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on July 9, 2002, at Reel 2540, Frame 0138;

WHEREAS, Pledgor has paid all of its outstanding indebtedness to Pledgee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Pledgee hereby terminates the Trademark Security Agreement and the Loan Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.

Pledgee represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks; (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register the foregoing, or any trade name or assumed name, other than those of the foregoing set forth on Schedule A (attached hereto), in any jurisdiction throughout the world.

Pledgee shall, at Pledgor's expense, take all further actions, and provide to Pledgor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Pledgor to more fully and effectively effectuate the purposes of this Release.
