

**TRADE-MARKS ASSIGNMENT AGREEMENT**

This Trade-Marks Assignment Agreement is dated as of 12:01 AM on the 26<sup>th</sup> day of May, 2003

**BETWEEN:**

**ConAgra Frozen Foods Ltd.**, having its principal place of business at 570 Curé Boivin, Boisbriand, Québec, J7G 2A4;

(hereinafter referred to as "Assignor")

**AND:**

**ConAgra Grocery Products Ltd.** having its head office at 80 Tiverton Court, Suite 600, Markham, Ontario, L3R 0G4;

(hereinafter referred to as "Assignee")

**WHEREAS**, the Assignor and the Assignee have entered into a Winding-Up and Dissolution Agreement (the "**Winding-Up Agreement**") dated as of 12:01 AM on May 26, 2003 pursuant to which the Assignor has agreed to assign and transfer to the Assignee all of its assets and liabilities (the "**Transferred Assets**");

**WHEREAS**, the Assignor and the Assignee have agreed to sign and execute all further acts, instruments or documents to evidence any transfer or assignment of the Transferred Assets in accordance with Section 5 of the Winding-Up Agreement.

In consideration of ONE DOLLAR (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the parties, the parties agree as follows:

1. **Assignment:** The Assignor hereby sells, conveys, transfers, assigns and delivers to the Assignee all of the Assignor's rights, title and interest in and to the trade-marks and trade-mark applications described in Schedule 1 and all goodwill related thereto (the "**Trade-Marks**").
2. **Registration:** The Assignor hereby authorizes the issuance of any and all registrations for the Trade-Marks to the Assignee.
3. **Execution of documents:** The Assignor hereby covenants and agrees, without further consideration, to do all such lawful acts and things and to execute such further lawful assignments, documents, assurances, applications and other instruments as reasonably may be required by the Assignee to obtain any and all registrations for the Trade-Marks and to vest the same in the Assignee.
4. **Counterparts:** This agreement may be executed in one or more counterparts, each of which will be deemed to be an original copy of this agreement and all of which, when taken together, will be deemed to constitute one and the same agreement.
