(the "Corporation"), for the purpose of amending the Articles of Incorporation of the Corporation, in accordance with The General and Business Corporation Law of Missouri, does hereby make and execute this Certificate of Amendment of Articles of Incorporation and does hereby certify that:

- I. The name of the Corporation is Gilcrest Equipment Co.;
- II. The amendment set forth below was adopted by the directors of the Corporation on December 30, 2003;
- III. The amendment set forth below was adopted by the stockholders of the Corporation on December 30, 2003;
- IV. The following resolution of the Board of Directors, approved by the stockholders, sets forth the amendment:

RESOLVED, that Article First of the Articles of Incorporation of the Corporation be amended to read as follows:

FIRST: The name of the corporation is JMG Equipment Co.

V. Three Thousand Sixty-Nine (3,069) shares of stock of the Corporation were outstanding and Three Thousand Sixty-Nine (3,069) shares of common stock were entitled to vote on the amendment.

VI. The foregoing amendment was, in accordance with the provisions of The General and Business Corporation Law of Missouri, adopted by written consent signed by the sole shareholder of the Corporation entitled to vote thereon, such consent having the same force and effect as a unanimous vote of the shareholders thereon at a meeting duly called and legally held. Accordingly, the number of shares of common stock of the Corporation voted for the amendment was Three Thousand Sixty-Nine (3,069) and the number of shares voted against the amendment was zero.
