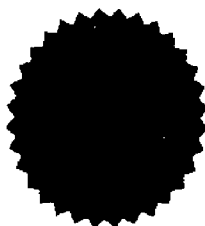

Seagate Removable Storage Solutions LLC, a limited liability company organized and existing under the laws of the State of Delaware (the "Company"), hereby certifies as follows:

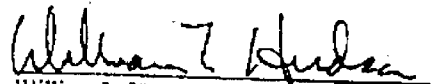
1. The name of this Company is Seagate Removable Storage Solutions LLC.
