ASSIGNMENT

THIS ASSIGNMENT, made and effective the date of execution hereof, is by and between Harry J. Bosworth Company, an Illinois corporation, with a place of business at 7227 North Hamlin Avenue, Skokie, Illinois 60076 (hereinafter "Assignor") and Majestic Drug Co., Inc., a New York corporation, with a place of business at P.O. WHEREAS, Bosworth is the owner of United States Trademark Registration Number 670,367 for the mark D.O.C. in connection with "preparation for cleaning, deodorizing and antisepticising dentures" claiming first use at least as early as January 1, 1940 ("the Trademark");

WHEREAS, Assignor desires to transfer and assign all right, title and interest in and to the Trademark to Assignee; and

WHEREAS, Assignee desires to purchase all of Assignor's rights to the Trademark;

THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor assigns to Assignee all of Assignor's right, title, and interest in and to the Trademark, including all common law rights and trademark registrations, together with the goodwill symbolized by any use of the Trademark, and the right to sue third parties for and recover damages from past and future infringement of the Trademark.

I hereby authorize the Commissioner of Patents and Trademarks of the United States, and any official of any other country empowered to issue trademark registrations, to record this Assignment, and to issue or transfer all relevant trademark registrations to the Assignee as owner of all right, title and interest therein, or otherwise as the Assignee may direct, in accordance with the terms of this Assignment.
